NOTICE OF CHANGES TO DESIGNATED INVESTMENT ALTERNATIVES

The purpose of this Notice is to inform you that American Century is changing the name of its LIVESTRONG funds to One Choice funds effective May 31, 2013. This change affects the Notice of Default Investments and the Investment Options Comparison Chart.

CHANGES TO DESIGNATED INVESTMENT ALTERNATIVES

As a participant or beneficiary in the Johns Hopkins University 403(b) Plan or the Johns Hopkins University 403(b) Plan for Residents, Interns and Postdoctoral Fellows, you previously received an Investment Options Comparison Chart identifying the designated investment alternatives available under the Plan as required under ERISA Section 404(a)(5). The change in name of the American Century funds changes the information on this Comparison Chart.

Accordingly, this Notice formally amends the Comparison Chart that we previously provided to you on or before August 30, 2012. Please attach this Notice to your copy of the Chart.
