Group Life Insurance Plan: The plan has a contract with Metropolitan Life Insurance Company to pay all claims incurred under the terms of the plan. The total premiums paid for the year ending December 31, 2011 were \$3,648,777.

Long Term Disability Plan: The plan has a contract with the Hartford Life Group Insurance Company to pay all claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2011 were \$4,683,549.

Health Maintenance Plan: The plan has a contract with Kaiser Permanente to pay all claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2011 were \$2,368,052.

Group Dental Plan: The plan has contracts with United Concordia Companies to pay all claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2011 were \$554,285.

Travel Accident Insurance Plan: The plan has a contract with Hartford Life and Accident Insurance Company to pay all claims incurred under the terms of the plan. The total premiums paid for the year ending December 31, 2011 were \$109,853.

Short Term Disability Plan: The plan has a contract with the Hartford Life Group Insurance Company to pay all claims incurred under the terms of the plan. The total premiums paid for the year ending December 31, 2011 were \$2,305,022.
