The Johns Hopkins University 403(b) Plan

By law, employers are required to provide a summary annual report for various benefit plans. The content, and even much of the wording, is specified by the Employee Retirement Income Security Act of 1974 (ERISA) and Labor Department guidelines.

This is a summary of the annual report for the Johns Hopkins University 403(b) Plan, EIN: 52-0595110 Form 5500, for the period 07/01/2013 to 06/30/2014. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$4,069,510,022 as of June 30, 2014, compared to \$3,475,537,661 as of July 1, 2013. During the plan year the plan experienced an increase in its net assets of \$593,972,361. This increase includes unrealized appreciation in the value of plan assets at the end of the year and the value of the assets at the beginning of the year or the cost of the assets acquired during the year. During the year, the plan had total income of \$816,965,636; including employer contributions of \$109,635,699, participant contributions of \$76,511,650 and earnings from investments of \$105,936,673.

Benefits are provided by a trust and insurance annuity contracts. Plan expenses were \$222,993,275. These expenses included \$238,307 in administrative expenses and \$222,754,968 in benefits paid to participants and beneficiaries.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report.
