## Summary Annual Report The Johns Hopkins University Income Deferral 403(B) Plan for Residents, Interns and Postdoctoral Fellows

By law, employers are required to provide a summary annual report for various benefit plans. The content, and even much of the wording, is specified by the Employee Retirement Income Security Act of 1974 (ERISA) and Labor Department guidelines.

This is a summary of the annual report for The Johns Hopkins University Income Deferral 403(B) Plan for Residents, Interns and Postdoctoral Fellows, EIN: 52-0595110 Form 5500, for the period 01/01/2016 to 12/31/2016. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## **Basic Financial Statement**

Benefits under the plan are provided through a trust fund and insurance. The value of plan assets, after subtracting liabilities of the plan, was \$41,591,681 as of December 31, 2016, compared to \$36,782,916 as of January 1, 2016. During the plan year the plan experienced an increase in its net assets of \$4,808,765. This increase includes unrealized appreciation (depreciation) in the value of plan assets, that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of the assets acquired during the year. During the year, the plan had total income of \$6,406,650; which includes Employer contributions of \$722,288, participant contributions of \$2,409,950, "other"/rollover contributions of \$217,293, unrealized appreciation of assets of \$25,497, and earnings from investments of \$3,031,622. Plan expenses were \$1,597,885. These expenses included \$1,597,885 in benefits paid to participants and beneficiaries.
