Travel Accident Insurance Plan:

The plan has a contract with Hartford Life and Accident Insurance Company to pay all claims incurred under the terms of the plan. The total premiums paid for the year ending June 30, 2009 were \$124,754.

Faculty and Professional (Senior) Staff Retirement Plan:

Basic Financial Statement

Benefits under the plan are provided by individually owned, fully vested mutual fund and annuity contracts issued by the Teachers Insurance and Annuity Association, College Retirement Equities Fund, Fidelity Investments, American Century Investment Services, Inc., Variable Annuity Life Insurance Company, and the Vanguard Group of Investment Companies. The total premiums paid for the plan year ending June 30, 2009 were \$136,659,707.93.
