## Summary Annual Report for the Travel Accident Insurance Plan Faculty and Professional (Senior) Staff Retirement Plan

By law, employers are required to provide a summary annual report for various benefit plans. The content, and even much of the wording, is specified by the Employee Retirement Income Security Act of 1974 (ERISA) and Labor Department guidelines.

### **Travel Accident Insurance Plan:**

The plan has a contract with Hartford Life and Accident Insurance Company to pay all claims incurred under the terms of the plan. The total premiums paid for the year ending June 30, 2010 were \$80,828.

### **Faculty and Professional (Senior) Staff Retirement Plan:**

This is a summary of the annual report for Johns Hopkins University Faculty and Senior Staff Retirement Plan, EIN: 52-0595110 Form 5500, for the period 07/01/2009 to 06/30/2010. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$2,398,507,790 as of June 30, 2010, compared to \$2,132,199,028 as of July 1, 2009. During the plan year the plan experienced an increase in its net assets of \$266,308,762. This increase includes unrealized appreciation in the value of plan assets, that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of the assets acquired during the year. During the year, the plan had total income of \$364,223,452; including employer contributions of \$88,050,994, and participant contributions of \$54,492,968 and earnings from investments of \$41,413,633. Plan expenses were \$97,924,690. These expenses included \$172,755 in administrative expenses and \$97,751,935 in benefits paid to participants and beneficiaries.
